Investment Profile- Sweet Potato

#### Overview

Sweet Potato (Ipomoea batatas) is a warm weather vegetable belonging to the convolvulaceae family originating from parts of Central and South America. It is the third most widely grown root tuber in Jamaica, after yams and cassava. The plant stores its food in its tuber, emanating in different colours- yellow, white and red. Optimal production of sweet potatoes occurs in sandy soils, warm climatic conditions, and nutrient and soil moisture availability. These provide the ideal medium to support maximum productivity, however due to soil's natural variability in structure and nutrients, technical soil tests must be simplified and engineered to suit the crop requirement.


The sweet potato is an excellent source of carbohydrate and is a major staple in the average Jamaican's diet. It is one of the most highly demanded tubers in Jamaica, required in the export and fresh food markets as well as in the agro processing industry. Traditionally, the majority of sweet potato produced on the island is consumed domestically with just over 2% making it to the export market. Overall only about 1% of the world's total sweet potato production is traded on the world market as it is used to satisfy domestic demand in most countries.

# **Areas Produced**

Sweet Potato can be cultivated island-wide but does best on fertile, friable, well-defined, free draining soils. The ideal production areas are St. Catherine, St. Ann, St. James and St. Elizabeth. Historically, the parishes of Manchester, St. Elizabeth and St. Ann have been the major producers, boasting approximately sixty nine percent (69%) of total production. The tuber is available all year round and matures in approximately 4 months.


#### **Cultivars**

Although numerous varieties of the tuberous root can be distinguished locally, the Uplifter, Quarter Million, Eustace, Big Red, Clarendon, Blue Bud and Dor are most popular; the beauregard variety was imported to boost production mainly for the export market. Tubers may have smooth or irregular ribbed surface and the skin and flesh may range from pure white through cream, yellow, orange or pink to a very deep purple depending upon the amount of various carotenoid pigments present and the presence or absence of anthocyanins (plant pigments). Jamaican consumers give preference to smooth, red skin types with white flesh. Among the local varieties, the Uplifter with its yellow flesh is in high demand by the ethnic population in the export market.

#### **Cost of Production**

According to <a href="www.rada.gov.jm">www.rada.gov.jm</a>, the cost to establish a hectare of sweet potato is \$680,000. Marketable yield is 17,000 kg with a cost of production of \$40.00 / kg. Sweet potato will fetch prices ranging between \$80 and \$192.


Investors in sweet potato production can expect a ROI of at least 100%.






## **Jamaican Sweet Potato Exports**

Over the period 2013-2016 Jamaican sweet potato exports averaged 1,316,952 kg. Combined, the United States, Canada and the United Kingdom accounted for over 90% of total exports.







According to the Statistical Institute, Jamaica exported 1,257,795 Kg (1257.795 tonnes) of sweet potatoes in 2016; this represents 0.7% of total world exports for sweet potatoes ranking Jamaica 20<sup>th</sup> in exports of the product.

The United Kingdom, Netherlands and Canada imported the highest value of sweet potatoes over the past three years with UK demand growing exponentially. With the United Kingdom holding the highest share of Jamaica's sweet potato exports this presents a major opportunity for Jamaica. The value of UK imports of sweet potato have grown by 31% between 2012 and 2016 and in just one year -2015-2016, the value of UK sweet potato imports have grown by 11%. The United Kingdom is the largest importer of sweet potatoes accounting for 24.8% of world imports.

Jamaica's other major market Canada, which accounts for 10.3% of the world's sweet potato imports has also seen a growth in the value of imports of 4% over the 2012 to 2016 period and 2% from 2015 to 2016.

As sweet potato is not highly cultivated in Europe, it presents the greatest opportunity for Jamaica to increase its production to meet the rapidly growing demand for the produce.


Based on rising demand, Spain has ramped up production and the value of UK imports from Spain has grown significantly between 2012 and 2016.

Even with increased production in Spain the UK demand for the produce still presents a huge opportunity for investors in Jamaican sweet potato production. The proliferation of ethnic and exotic food in restaurants, dedicated sections in supermarkets and food stores geared at supplying fresh produce, the world demand is expected to continue to trend upwards.

# **Grading**


The Ministry of Industry Commerce Agriculture and Fisheries of Jamaica outlines that sweet potato quality is primarily based on firmness, colour, shape, uniformity and maturity. Bulbs should be free from decay, diseases, defects, pest and pest damage. Sweet potatoes should be of similar varietal characteristics, clean, mature, fresh and firm.

#### Yield

The world's top producer of sweet potato is China with a yield of 21.51 (t/ha) in 2016 and total production of 2,126,989 tonnes for the same year. Most of China's production is used in the domestic market for animal feed.


Jamaica's yield for the crop is on par with the world's top three producers and significantly higher than Uganda and Nigeria who round out the top five counties with the highest production.

## **Local Market**



Sweet potatoes in its fresh form is currently the highest form of exports; there are however a number of processing opportunities for investors in sweet potatoes. In most developing counties like Jamaica, sweet potato is used as a substitute for rice and so it is being prepared in a number of forms.

# **Export Requirements**

Under the provisions of the Agricultural Produce Act and international trading partners, companies wishing to export sweet potato must:

- Register with the Companies Office of Jamaica.
- Utilize a certified packing house the Packing House is a building where all the operation regarding: washing, treating, drying and packing of the sweet potato or any fresh produce takes place.
- Register with JAMPRO.

There are also country specific requirements, some of which are outlined in the table below:

To fulfil this obligation, European importers will require you to provide proof of the origin of all fruits and vegetables with a Bill of Lading, phytosanitary certificate, packing list and custom documentation. Shipment of agriculture produce should be accompanied by a EURO 1 form (non-phytosanitary requirement)	Pesticide residues are one of the crucial issues for fruit and vegetable suppliers. To avoid health and environmental damage, the European Union has set maximum residue levels (MRLs) for pesticides in and on food products. Products containing more pesticides than allowed will be withdrawn from the European market. Reduce the amount of pesticides by applying integrated pest management (IPM) in production. IPM is an agricultural pest control strategy that includes growing practices and chemical management.
		The most commonly requested certification is GLOBALG.A.P., a pre-farm-gate standard that covers the whole agricultural production process, from before the plant is in the ground to the non-processed product (processing is not covered). Whether GLOBALG.A.P. is required also depends on the destination country, market conditions and market channel. For example, it has become nearly impossible to supply northern Europe without GLOBALG.A.P. since it is a standard requirement for most supermarkets.
Canada	Potatoes should be the standard of U.S. Extra No. 1 grade or U.S. No. 1 grade -be properly packed; - not be artificially coloured; - have similar varietal characteristics	Potatoes from other countries must be inspected and certified by CFIA upon arrival to meet Canadian minimum import requirements.  Importation of any commodity (including root crops) in association with soil from areas other than the continental U.S. is prohibited. Root crops must be free from soil. No loose soil may be present inside or adhering to the outside of shipping containers, bins or packaging. A fine film of dust (as from dirty wash water) is permitted.

U.S. Extra No.1 Length shall be not less than 3 inches or more than 9 inches. Maximum weight shall be not more than 18 ounces. Maximum diameter shall be not more than 3-1/4 inches. Minimum diameter, shall be not less than 1-3/4 inches.

U.S. No.1 Maximum diameter shall be not more than 3-1/2 inches. Maximum weight shall not be more than 20 ounces. Length, unless otherwise specified, shall be not less than 3 inches or more than 9 inches. Minimum diameter, unless otherwise specified, shall be not less than 1-3/4 inches.

Compliance with the provisions of grading standards shall not excuse failure to comply with the provisions of the Federal Food, Drug and Cosmetic Act, or with applicable State laws and regulations.

Sweet Potato exports to the United States are guided by regulations which make it difficult for Jamaica to access the market in a cost effective way.
